隨著「德國工業 4.0」戰略的發佈，工廠內搬運作業逐漸也邁向無人操作方式，其中無人搬運車 Auto Guided Vehicle (AGV) 將得以廣泛應用，同時其安全性也變得更加重要。

“CE” 標誌是一種安全驗證標誌，被視為製造商打開並進入歐洲市場的護照。凡是貼有“CE” 標誌的產品方可在歐盟各成員國內銷售，無須符合每個成員國的要求，因此實現了商品在歐盟成員國範圍內的自由流通。

同樣，無人搬運車 (AGV) 進入歐盟市場，必須合法地取得 CE 驗證標誌的使用資格，這也就意味著無人搬運車 (AGV) 產品必須符合相關歐盟指令的要求。

Following Germany's announcement of the Industry 4.0 strategy, in-plant handling will gradually evolve towards unmanned operation. Auto guided vehicles (AGVs) will be widely applied, and their safety will be extremely important.

The "CE" mark is a security certification label regarded as a passport for manufacturers to enter into and penetrate the European market. Any product bearing the "CE" mark can be sold in every EU country without the need to meet the requirements of every EU member, thus enabling the free circulation of products from one member country to another.

By the same token, an AGV must be legally qualified to bear the CE certification mark before entering the EU market. This also means that AGV products must satisfy the requirements set forth by the relevant EU directives.
